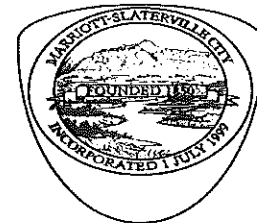

October Gardening Tips

October is a great month to prepare your gardens for winter. Here are some things to do this fall, after frost.

1. Cut perennials, except grasses, Lavender and roses.
2. Pull spent annuals.
3. Weed and clean up flower beds and garden areas.
4. Apply new mulch now or in early spring.
5. Apply pre-emergent to edges and perennials beds.
6. Till garden, cut lawn short, compost and fall fertilize.

UDOT continues to study both Alternatives A and B as part of the Draft Environmental Impact Statement (Draft EIS). Currently, UDOT is drafting chapters of the Draft EIS document and conducting a detailed analysis on impacts such as noise, water quality, and air quality. The result of this in-depth analysis will be reflected in the Draft EIS. A final decision is not expected until 2013.
