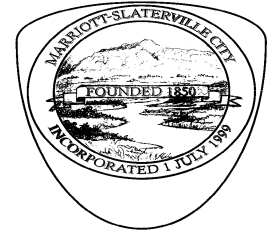

- **Irrigation.** Weber Basin Water Conservancy District may shut-off irrigation water as soon as October 1st. Our city special district will leave on pressurized secondary water for residents and businesses to use until the water supply is exhausted. Please plan and prepare now for irrigation to end the first part of October.
- **September Road Projects.** Various roads throughout the city will be painted and potholes repaired in preparation for winter.
- **2016 Elections.** Weber County administers the 2016 elections. For election questions contact the Weber County Clerk at: 801-399-8400.
- **Parks Closing.** The city parks close and will be winterized on October 15th.
- **Recycling Program.** Marriott-Slaterville residents recycle. Recycling is every other week, which will be September 12th and 26th.
