The site and BMPs will be inspected on a regular basis to ensure compliance with this Permit and SWPPP. The applicant is responsible for permit and SWPPP compliance for the entire site and for the duration of the work and/or construction activity. The applicant is responsible for the actions of the subcontractors, vendors, delivery personnel, and others who will be working on the site. The applicant is responsible for any material that leaves the site.

I hereby acknowledge that I have read the instructions and provisions of the Permit, applicable City Ordinances, and the City's Storm Water Checklist, and agree to follow the terms and conditions of this Permit, the SWPPP, and applicable ordinances, rules, and regulations. Based on my inquiry of the person or persons directly responsible for gathering the information, the information submitted is, to the best of my knowledge and belief, true, accurate, and complete.

A legally authorized representative of any applicant that is a corporation, partnership, limited liability company, trust, or other legal or governmental entity must sign the application on behalf of and as authorized by the legal or governmental entity. Separate documentation shall be provided regarding such authorization.

Nothing contained in this packet is intended to relieve any person or entity from any obligation to comply with applicable federal and state laws and regulations pertaining to clean water and/or storm water runoff.
