Historic Cabin

In 1855, the Edwin Ward and Leah Oakley Smout Family moved to Ogden, Utah, after arriving in Salt Lake City in 1854. There Edwin purchased a log home for \$50 and paid \$25 to have it moved to Mound Fort in Ogden. Shortly thereafter, Edwin began farming in Slaterville, and later moved his family and cabin to this farm in April 1858. By 1870 there were eleven (11) children living in the cabin. In 1882, Edwin built a larger home around the small cabin where they lived. This cabin has been located to City Hall Park and restored by the City. The cabin has been filled with pioneer era artifacts by the Susan Marriott Camp of the Daughters of Utah Pioneers, Weber Northeast Company. The cabin is located at 1570 West 400 North.
