Road Projects

This year there will be a number of road projects in the community. To the resident who sent an anonymous letter to the City about potholes on S.R. 126 and 400 North, please resend your letter to UDOT. This is a UDOT intersection and not under the jurisdiction of the City. UDOT will be widening the intersection on S.R. 126 and 700 South. UDOT may also be making improvements on S.R. 126 and 400 North. Please plan for significant delays during construction and use alternate routes.

Marriott-Slaterville City will be upgrading utilities and reconstructing 1700 South. The road will be entirely rebuilt, including the sub-grade. It is anticipated this project will take about two (2) years to completed and traffic may be limited to residents and businesses only during construction. The road may be closed at times and there will be significant delays and impacts to traffic in the area as a result of the construction. Please plan alternate

routes. The City also has several chip seal projects throughout the community.

Local Updates

- Utility Rates. City sewer, storm water, secondary water, garbage and recycling rates will remain the same thru the end of June 30 fiscal year.
- Dark Sky. The City adopted a Dark Sky
 Ordinance in 2017. Light pollution affects sleep
 patterns and health. Please turn off your lights.
 Replace lights that are not compliant. If you have
 questions refer to the International DarkSky
 Association: darksky.org.
- Nuisances. Performance standards are regulations that limit nuisance activities such as loud noises, vibrations, and construction during hours when people are sleeping. Please be a courteous neighbor or business and limit disturbances at night or early morning.
- Dogs. Please walk dogs using a leash and keep your dog from excessively barking. Too many neighbors are experiencing aggressive dogs while walking in the community.
- Ride Safe. It is legal to use an OHV only on local roads for operators who have a valid license, insurance, and registration. OHVs are still prohibited on state roads, parks, and trails. State law now requires OHV operators to complete the Utah Off-Highway Vehicle Education Course.
