Spring Clean-up

Its time again for Spring clean-up! Dumpsters will be located at Marriott Park and Slaterville Park from **April 26-27**. Use these dumpsters to clean-up your yard and the community. It is required that you put all debris inside the dumpster. Do not leave any debris on the ground. This is a complimentary service. Please be considerate of others using the dumpster. Spring Flooding

The City does not anticipate flooding this year. However, the spring run-off may present surprises. The City and County will monitor the water levels in the Ogden River, Weber River, Mill Creek, Four Mile Creek, and Six Mile Creek. Please take precautions in the event of flooding. Basements and crawl spaces are affected by high ground water levels in our area. Those living near flood prone areas, rivers, streams, and waterways may be impacted. Secondary Water

Irrigation companies in the City will soon be turning on secondary water. Each irrigation company operates independently and has its own schedule to turn on irrigation water. The City will turn on its pressurized irrigation system once the irrigation company provides the City with water. The City anticipates all systems will be on by May 1, 2025. There may be some delays as irrigation companies work on cleaning and piping sections of their ditch. There are no drought restrictions this year.

Local Updates

- ► **Burn Permits.** Weber Fire District reminds residents that the Open Burn window for yard clean-up is March 30 to May 30. For a burn permit visit: air.utah.gov/OpenBurning/form/. Burn permits are issued by the Utah Department of Environmental Quality.
- Lock it up! This time of year brings a spike in burglaries and thefts. The Weber County Sheriff asks you to lock up your property. Lock your car. Lock your doors. Lock your garage. Bring in your mail and packages after delivery.
- ► **Roads.** Pot holes that formed over winter are being filled and repaired. Please report potholes to the City Office at 801-627-1919. Drive safely.
- Parks. Park reservations start on April 15.
